- A 30 day written notice must be submitted to Footsteps Dance Studio, L.L.C. management when dropping a class. Monthly tuition will continue to be billed until the written notice has been received.
- Recital costume payments are due in full in December for the June annual dance production. Once the costume payment is made participants of the annual production agree to commit to the rest of the season.
